Fines

The below fines refer to sections in the NIF Competition Rules & Regulations.

Home Team Responsibilities

- Failure to arrange an alternative venue \$250 per offence
- Deficiency in ground \$100 per offence
- Failure to provide approved Match Balls \$100 per offence
- Failure to post results to Competition Administrator \$100 per offence
- Failure to set up field as per competition nomination form \$250 per offence

Ineligible Player

- Playing an ineligible Player \$200 per offence
- Use of false ID tag (Team Official) \$200 per offence

Playing for Another Club \$500 per offence

Player Bringing Code into Disrepute \$1000 per offence

Inducement to Bring about a Result \$2000 per offence

Ground Official

- No ground official at match \$100 per offence

Players Uniform/Gear Requirements

- Failure to have playing strip approved by NIF \$200 per strip

Kick Off Times

- Failure to obtain consent for time change \$50 per offence

Forfeited Fixtures \$200 per offence

Abandoned Fixtures/Spectator Interference

- Fine – Player \$500 per offence
- Fine – Club \$1000 per offence
- Fine – Person \$500 per offence

Mass Walk-Offs \$1000 per offence

Refusing to start a Fixture \$1000 per offence

| • Appeal to NNSWF (non-refundable) | \$1000 |
| • Appeal to FFA (non-refundable) | \$2000 |
| • Request for a Grievance Hearing by Competition Administrator (non-refundable) | \$250 |
| • Grievance Appeal Fee – NIF Disciplinary Chairman (non-refundable) | \$500 |
| • Grievance Appeal Fee – NNSWF | \$1000 |
